



## AVECS™ RE-ACT SAMPLE WARRANTY

AVECS warrants its product, **AVECS RE-ACT**, to be free from material defects and that the product conforms to its specification of ceasing moisture migration and the de-bonding of floorcoverings from the concrete slab itself or from a ground source for a period of fifteen (15) years when project uses both **AVECS RE-ACT** & an AVECS approved crack fill. The warranty is in effect from date of installation by an approved **AVECS** certified crew. The warranty is provided in good faith if **AVECS** products are installed according to and in compliance with **AVECS** specifications, spread rates and recommendations. When installation occurs of finishes specifications for moisture sensitive materials must be adhered to according to RFCI/ACI guidelines. **AVECS** reserves the right to inspect and test all materials to determine root cause of problem. If the **AVECS RE-ACT** product fails to cease moisture migration either out of or through the treated slab within the warranty period **AVECS** will, at its own expense, repair the affected area with the same or comparable flooring finish at a pro-rated rate at **AVECS** discretion. **AVECS** makes no other warranty, either implied or expressed and cannot be held liable for acts of nature, inferior concrete, concrete additives, cracks or voids and slab cracks that resulting from prior to and/or after the product installation nor are we responsible for control and/or expansion joints as sources of moisture migration. The sole remedy of the purchaser for any and all claims regarding **AVECS** product(s) alleged breach of warranty/contract, negligence, liability or otherwise is the remediation of affected area topically with **AVECS RE-ACT** product and the repair and/or replacement of floorcoverings of said area(s), solely at the discretion of **AVECS** Inc. All claims regarding this product(s) must be submitted in writing to **AVECS** LLC within fifteen (15) years of discovery of potential issue. In no case will **AVECS** be liable for punitive, consequential, special or incidental damages which would include loss of profit or use of area due to down time. Any disputes/claims resulting from use of these products or relating to provisions of the warranty must be arbitrated in using the services of a neutral dispute resolution service upon which the buyer and seller agree, or if agreement cannot be reached then the services of the American Arbitration Association will be utilized.

Manufacturers claim/warranty policy is as follows: claims will not be considered until all flooring installation and adhesives have been inspected by either an **AVECS** representative, independent flooring inspector of our choice and data sheets/original specifications of said materials are provided to **AVECS** from flooring contractor. **AVECS** warranty has no upper limits on either Calcium Chloride (ASTM F 1869) or Relative Humidity (ASTM F 2170) therefore only recognizes ASTM D-5084 and/or ASTM D-4263 to prove its success and issue warranty. All accounts must be paid in full before warranty is issued by **AVECS** LLC.
